

Drop-In Care Admission and Agreement

On behalf of myself (parent/guardian), my spouse and each child designated (My "Child") enter into this Admission Form Agreement with Little Imaginarium LLC, a California Limited Liability Corporation, regarding the provision by Little Imaginarium of a supervised, indoor play environment for my Child _____

1. Facility Use: Subject to this Agreement and other terms as drop-in, short-term child care for my Child on a flexible and limited time basis (**A max of 4 hours care per child, per day**) which includes use of facilities and participation in art and play activities. Little Imaginarium does not take field trips or provide transportation.

2. Future Visits: This Agreement, the Registration Form and the Release will be kept on file at Little Imaginarium and still continue to constitute binding obligations for any future visits my Child may make to Little Imaginarium. However, this Agreement does not obligate Little Imaginarium to continue to provide services and Little Imaginarium reserves the right to refuse admission to any child for any reason without liability.

3. Payment: Payment for Little Imaginarium services will be due at the time of each check-out and calculated by multiplying the time elapsed from check-in to check-out by the rates agreed upon at the time of the visit and for any other services such as; family registration fee, meals and retail items (see rate chart below). Little Imaginarium may charge a service fee to any unpaid invoices. No refunds are given. Any changes in fees will be posted for at least 30 days.

NOTE: Breakfast/Lunch can be brought from home, but must be labeled and must be peanut-free.

4. Late Pick-ups: First late will be no charge. I agree that subsequent late arrivals are subject to the following charges: \$1 per minute, up to 30minutes. After 30minutes, regular hourly rate will apply, plus \$1 per minute until parent/guardian arrives at facility. Late payment will be due upon pick-up.

5. Sign In/Sign Out Policy: I agree as Parent/Guardian I am required to sign in and sign out my child without exception for every pick up and drop off at facility. I also understand that my child will only be released to those authorized persons listed under the emergency contact section of the registration form.

6. Health Policy: My Child is in excellent health and physical condition and has no medical, psychological, physical or mental condition which has not been disclosed to Little Imaginarium on the attached registration form. My Child does not have any infectious, contagious or communicable diseases. I understand immunizations and tuberculosis testing verification is not required for attendance at a drop-in center.

7. Illnesses: In the event my Child becomes sick with a contagious illness after visiting Little Imaginarium and the visit occurred during the gestation period of such illness, I agree to notify Little Imaginarium as soon as possible to enable Little Imaginarium, in its discretion, to notify each family of all the children who may have been exposed. NOTE: Children who are sick will not be allowed to participate until symptoms have ceased. Children should remain home until they feel well enough to participate in a social play environment.

8. Medical Procedures:

- a) General Medical Guidelines/Discretion: Although Little Imaginarium tries to provide a safe environment it is possible my child could get injured. In such event, I authorize Little Imaginarium to follow its internal procedures, including simple first aid as reasonably appropriate; however, I understand Little Imaginarium shall not be required to strictly follow those guidelines when, in Little Imaginarium judgment, circumstances may require otherwise.
- b) Medical Authorization: In the event Little Imaginarium determines emergency medical attention is necessary for my Child, Little Imaginarium is authorized by me or whomever signs my Child in for the day, to act as an agent for me and have my permission for my Child to be attended by a physician in such circumstance as Little Imaginarium deems necessary.

9. Discipline: Corporal punishment is strictly prohibited by law and is a violation of My Child's personal rights. Little Imaginarium will address any disciplinary concerns with a positive reinforcement model that

allows My Child to grow more confidently, self-reliant and independent. I understand that discipline will be handled with kindness, consistency and understanding.

10. Safety/ Indemnity: I agree that Little Imaginarium may take action which it considers prudent to protect the safety of my Child and other children visiting Little Imaginarium. I further agree to indemnify, defend and hold Little Imaginarium (and its Officers, Directors, Agents and Employees) harmless from and against all actions, claims, or liability, including attorney fees and court cost, directly or indirectly caused by my Child or resulting from any omission made by me in completing the Registration Form.

11. State of California Licensing Requirements (Title 22 Section 101195I (b) and (c))Dept. of Social Services - Community Care Licensing: The Department or licensing agency shall have the authority to interview children, or staff, and to inspect and audit child or facility records without prior consent; and to observe the physical condition of the children, including conditions which could indicate abuse, neglect, or inappropriate placement, and to have a licensed medical professional physically examine the children.

12. Additional Requirements:

- a) As a condition to my use of Little Imaginarium, I have accurately completed and signed the Registration form and Release. I understand that Little Imaginarium will rely on this information in caring for my Child.
- b) I agree to pay all cost and attorney fees arising out of any action relating to this Agreement, the Registration Form or the Release for collection purposes or otherwise.

RELEASE

I, on behalf of myself (parent/guardian), my spouse and each child designated on the Admission Form Agreement (my "Child"), waive and release all rights, causes of action and claims against Little Imaginarium, LLC, its Officers, Directors, Agents and Employees, for any and all loss of or damage to property or injuries suffered by my Child during the time my Child is visiting Little Imaginarium, excluding any gross negligence and intentional misconduct. I understand that the provision of child care may contain some risk of injury to persons and damage to property, and that by signing this release I engage Little Imaginarium other than those contained in the written information supplied to me by Little Imaginarium.

I have been given the opportunity to ask questions and obtain answers to my satisfaction regarding any and all aspects of Little Imaginarium and the Release including, but not limited to, future risks, complications and costs. By signing this Release, I have not relied on my promises or statements made by Little Imaginarium other than those contacted in the written information supplied to me by Little Imaginarium.

I understand that this Release will be kept on file at Little Imaginarium and will continue in effect for this and any future visits my Child may make to Little Imaginarium.
